



**DUES STRUCTURE:**

Commerce Lexington's investment levels are based on the size of the company. This is determined by counting the total number of employees in a business. Membership investments must be paid in full at the time of application. Payment options include cash, check, MasterCard, Visa, American Express, or Discover. Checks should be made payable to Commerce Lexington. If payment is by credit card, verify the expiration date and billing zip code and CSV code (three digit number on back of card for V/MC and four digit number on front of card for AMEX).

Your prospective member is welcome to use our online application to join, however, they must put your name in the "referred by" section for you to receive credit for the sale.
