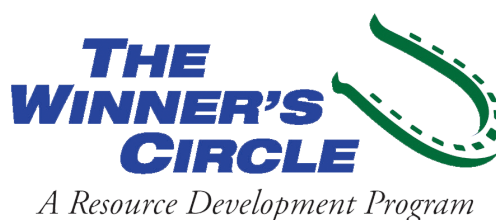

## About Winner's Circle

Winner's Circle is our annual volunteer driven revenue (sales) campaign. Member volunteers recruit new members, upgrade existing members, and secure event sponsors, publication advertising and trade agreements. Volunteers are rewarded for their hard work in the campaign.

The program is referred to as a "total resource campaign", meaning that it allows volunteers to promote the complete menu of Commerce Lexington's resources available to the business community; membership, upgraded membership (providing an extra level of exposure), and marketing through event and publication sponsorship.

Leading this year's initiative is Becky Reinhold of Bluegrass Sotheby's International Realty, who will serve as Chair of the Winner's Circle program. The Winner's Circle program provides a great opportunity for member companies to find marketing opportunities and sponsorships that meet their promotional needs and budget.

### Purpose

This campaign allows us to provide new and enhanced programs and member benefits. Winner's Circle has produced over \$10.5 million in the last 18 years. The dollars raised in the annual Winner's Circle campaign represent 30% of the Chamber operating budget. You can see why this campaign is important to Commerce Lexington!

### Timeline

The 2020 Campaign will kick-off the week of September 14<sup>th</sup> and run until approximately December 7<sup>th</sup>, 2020. The deadline for WC 2020 sales may vary based on progress to target.

## Terms and Conditions & Key Contacts

- Volunteers are acting as representatives of Commerce Lexington, Inc. All interactions and solicitation practices should reflect positively on the volunteer and the company they represent as well as CLX.
- To receive campaign credit and cash incentives, volunteers must complete the sales process by asking for the commitment, completing and submitting correct paperwork with signatures, volunteer information documented and collecting payment.
- All trades must have the approval of the WC Director before campaign credit is awarded.
- After a contract is approved, CLX will follow up with the sponsor regarding benefits and needs to execute the partnership.
- **NEW MEMBERSHIP PROSPECTS:** Volunteers should email Dawn Flickinger at [dflickinger@commercelexington.com](mailto:dflickinger@commercelexington.com) or Diana Wilson at [dwilson@commercelexington.com](mailto:dwilson@commercelexington.com) to check the status of an account before contacting them for membership. This is for the purpose of eliminating duplication of efforts among Commerce Lexington Account Executives and Winner's Circle Volunteers during the active campaign months. Dawn or Diana will confirm if the account is already being actively worked by a volunteer or an AE. If it is already being worked, the volunteer will not need to work that prospect. If it is not being worked, we will flag the account with the volunteer's name so that it is secure for the duration of the campaign. At the conclusion of the campaign dates, all volunteer names will be removed from the prospect so that it is available for sale by any representative.
- **SPONSORSHIP/ADVERTISING PROSPECTS:** CLX does not assign accounts for the purpose of sponsorships or publication advertisers. Whoever brings in the signed contract receives the credit for the sale. As in all sales best practices, we want to be cautious about inadvertently putting the purchaser in an uncomfortable position if it this situation occurs.
- Should sales occur outside the WC timeline, approved sales will be reported and rewarded in the next campaign.
- CLX will recognize all producers for their approved sales in the WC Campaign.
- An IRS 1099 Form will be issued for all incentives.
- WC Renewals of sales made in the prior year campaign are protected until the designated renewal release date
- Sponsorship/Publication Renewals must be resold within the renewal period to avoid being "released." After the renewal deadline, CLX will release the sponsorship as available for sale unless otherwise noted on the Sold/Availability document.
- Qualifying membership renewals are automatically credited when the member dues are paid. This applies only to memberships that were originally sold or upgraded in a WC Campaign.

For Commerce Lexington, it's a story that started over 135 years ago. Although it was incorporated in 1881, the origins of the chamber of commerce in Lexington have been traced back to 1797, when John Postlethwait convened a meeting of the Lexington Society for the Promotion of Emigration. Commerce Lexington Inc. was formed in January 2004 with the merger of the Greater Lexington Chamber of Commerce, Lexington United, and the Lexington Partnership for Workforce Development.

### Dues Structure

Commerce Lexington's investment levels are based on the size of the company. This is determined by counting the total number of employees in a business. Membership investments must be paid in full at the time of application. See current structure below.

Level 1 – Entrepreneur (1-5 employees)	\$395 annually
Level 2 – Small Business I (6-10 employees)	\$485 annually
Level 3 – Small Business II (11-30 employees)	\$575 annually
Level 4 – Corporate (30-75 employees)	\$795 annually
Level 5 – Executive (75–100 employees)	\$1000 annually
Level 6 – Enterprise (100-250 employees)	\$1500 annually

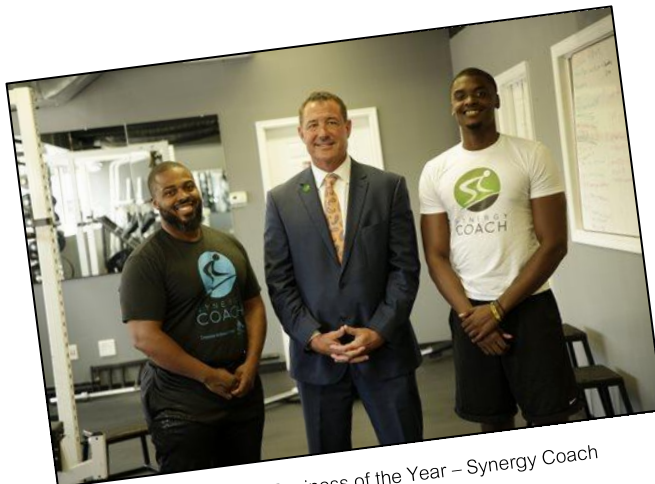


## Minority Business Development Program Sponsors

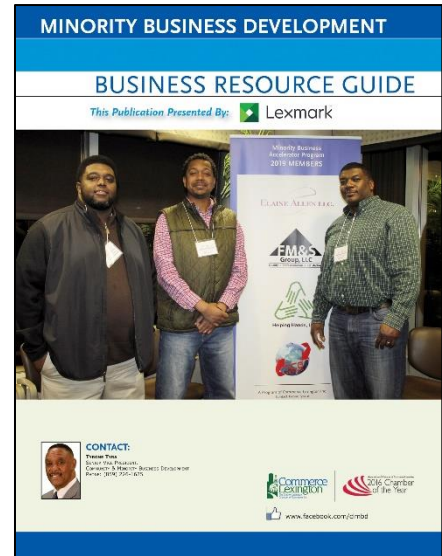

## In-Kind / Trade Sales

### What qualifies as an in-kind / trade sale?

Products and services that are included in Commerce Lexington's budget will be accepted as an in-kind sale in exchange for an event or publication sponsorship of equal value. Commerce Lexington will not accept a trade for membership or membership upgrade. Trade may also be restricted on premium level sponsorships.

### How are in-kind / trade sales valued?

The value is determined by what Commerce Lexington would have to pay to acquire the product or service at retail price. An equal value in event or publication sponsorship is provided in return. This is the amount of campaign credit given to the volunteer.

### Advance approval is required.

Due to our interrupted event schedule in 2020 we may have limited availability for trades in 2021. All in-kind products or services **must be approved in advance**. ### What information is required?

Specifics of all in-kind/trade sale arrangements must be made clear including description of product or service, value, what Commerce Lexington is providing in return (must be included on the contract) the expiration date, (minimum of one year from the date of contract), and any specific restrictions limiting use of trade. **No incomplete contracts will be accepted.**
